ABOUT THE CUSTOMER

Founded in 1994, Prodiel is an international technology company specialized in renewable energies and environmental management. Based in Seville, it has subsidiaries in Chile, Colombia, Peru, Brazil, Mexico, Panama, Morocco, Kuwait, Argentina and Guatemala, where more than 4,000 people work. The company has installed more than 16 million photovoltaic panels, being the company with the world record in the installation of panels in a single day - reaching 18,990 installations -, and has implemented more than 5,000 MW of power in the last five years. Prodiel focuses on four main areas of work that cover engineering, development, construction and maintenance. Its renewable projects reduce CO2 emissions by more than 9 million per year.

THE CHALLENGE

Prodiel was looking for a solution to prevent data leakage and protect files due to the criticality and importance of the information they handle. The objective was to have a solution that would allow controlling access to documents, even when they leave the security perimeter of the organization. "We were looking at other encryption solutions, but SealPath offered us the advantage of having control and tracking the data remotely, while other solutions only did so when the document was in our offices, once it was sent outside the organization, the control and traceability of the information was lost," said Alberto Solis, Head of Information Systems Planning and Strategy at Prodiel.

The first contacts with SealPath date back to 2017 due to the imminent implementation of the GDPR (General Data Protection Regulation) in Europe. "We wanted an internal tool that would protect the company's valuable information and intellectual property, allowing us to have a competitive advantage externally. Economically, SealPath was also a fairly viable solution compared to other tools, so we finally opted for it," says Solis.

THE SOLUTION

Prodiel has implemented SealPath Enterprise SaaS, a multi-platform and multi-device solution that offers automatic folder protection, integrated, securization through categories and automatic email protection. Among its features, this tool allows a quick start up with minimum IT resources. Moreover, its files and documents are protected locally, without the need to travel to the cloud, and it can be integrated with AD/LDAP through connector or ADFS, file servers and document managers, among other solutions.

The implementation of the SealPath tool has been progressive. In 2017 the first licenses were purchased and since then the number has been increased according to the needs of the organization. Initially, the solution was installed in the most critical areas such as Human Resources and then moved to the Operations and Bid Development area.

"Our goal is to continue stratifying the use of SealPath to all areas that handle information with some criticality. We have already covered the two most critical areas, but we want all departments to have the SealPath tool," said Solis.

The deployment has been carried out in two main phases. "In the first phase, the installation was carried out, which is very simple and does not require any ostentatious process. In practically one week it was up and running. In the second phase, the implementation took a little longer because we had a larger number of employees," says Solis.

THE BENEFITS

After several years of using the tool, Alberto Solis notes: *"The main benefit SealPath offers is the ability to protect personal information - for example, payroll and contracts - as well as the documents that carry the most weight for the company. We work with public or private tenders of large companies and this information is essential. Knowing that we have control over it both inside and outside the organisation is critical because it allows us to send it to third parties without risk".*

Luis Angel del Valle, CEO of SealPath, said, *"The three pillars of SealPath are ease of use, integration into large account and corporate systems, and protection automation. It is very satisfying to see a big client like Prodiel, these three features of SealPath, being able to have an automated protection in their file repositories and document managers, and all this simplifying the use by the users and without making them change the way they work".*

On the other hand, the use of SealPath within the company provides a double layer of security, not only providing permissions associated with file protection, but also allowing the document to move internally across the organization's different storage environments while still being protected.

In short, SealPath allows you to control the most sensitive documents both inside and outside the organization and to establish security policies on who can access the document and with what permissions, so that the user always has control over the information.
